Quarantine measures for travellers arriving from overseas during the pandemic of COVID-19

This is further to my even numbered letter dated 2021-09-28 on above subject.

Following amendment is made under the **Category** in **Section G.6** of the above guideline.

1. Travellers with a history of COVID-19 within **past six months** and if arriving only with a single dose of vaccine taken after two weeks of recovery and their unvaccinated children below 18 years.

Please note that the travellers of two years and above have to arrive with negative COVID-19 PCR Report done within 72 hours of embarkation. If they have a history of infection within **last three months**, instead of a PCR test, they could arrive with a negative COVID-19 Rapid Antigen Test report done within 48 hours prior to embarkation (as mentioned in **Section C** in letter dated 2021-09-28)

All other provisions in my letters dated 2021-09-28 and 2021-10-03 on above subject are in force.

This guideline is effective for the travellers arriving in Sri Lanka from 00:00 on 18th of October and for the travellers who have already arrived in Sri Lanka.
